

#### **Distributor Consolidation**


- Prepared analysis of performance over time of distribution utilities based on size

- Requested Town sponsorship of panel discussion at AMO


## **Residential Delivery Charge**

- May 1, 2016




# **Small Business Delivery Charge**




# **Large Business Delivery Charge**


